Dr. Blenning works as a family medicine physician at the OHSU Richmond Clinic and has a strong interest in LGBTQ Health with a focus on transgender care.

# Natalea Braden-Suchy, Pharm.D.

# Clinical Assistant Professor, Dept. of Pharmacy Practice, OSU/OHSU College of Pharmacy

She completed her pharmacy residency with an emphasis in ambulatory care at the University of Southern California. She has worked in a number of clinical settings with a diverse patient population, including immigrants, HIV patients and the homeless.

She is a pharmacologist specializing in the action of drugs in the central nervous system including cannabinoids and drugs of abuse. She has served as a member of the Retail Marijuana Scientific Advisory and the Governor's Task Force, authorized the State Legislature to study the medical and public health properties of cannabis.
