## **Key responsibilities:**

- Create 5 policy briefs using Behavioral Risk Factor Surveillance Systems Data to help inform the disability community and policy makers about the disparities affecting the disability community in Oregon.
- Generate literature review for ongoing manuscripts in preparation.
- Create graphical material from raw BRFSS data (bar charts, pie charts, and tables, graphics of trends) for policy briefs, data briefs, or demographic report.
- Synthesize research findings
- Assist with the development of PowerPoint presentations
- Contribute to other projects as needed
