Incomplete. The grade of I (Incomplete) is assigned when a student's work is of passing quality but incomplete for good cause. Assignment of an Incomplete grade is at the discretion of the course instructor, and should not be assigned unless the student is unable to complete the work because of good cause outside of the control of the student.

Criteria

A student may be assigned a grade of Incomplete by the Instructor when all of the following criteria apply:

- 1. Work in the course up to that point is at or above a pasing level ("B-" for required courses; "C" for electives).
- Reasons for assigning an "I" are acceptable to the Instructor. The student does not have the right to demand an "I." The circumstances must be unforeseen or beyond the control of the student. The Instructor may request appropriate medical or other documentation. In no case is an "Incomplete" grade given to enable a student to do additional work to raise a deficient grade.
- 3. A written agreement, signed by both the student and the Instructor, should include a statement of the remaining work to be done to remove the "I" grade, and the date, not to exceed one term from the end of the term of enrollment for the course, by which work must be completed in order to earn credit toward the degree. The Instructor may specify the highest grade to be awarded upon completion. The written agreement form is shown on the next page, and **should be submitted no later than end of business day on the last day of the term**. Copies of the signed agreement should be retained by the instructor, the student, and the Dean's Office.

Procedure

- 1. The student and instructor must complete and sign the attached Incomplete Agreement Form.
- 2. Submit the Incomplete Agreement Form to the Dean's Office at the address below **no later than end of business day on the last day of the term**.
- 3. To remove the Incomplete, the Instructor must contact the Dean's Office (sphregistration@ohsu.edu) to obtain a "Removal of Incomplete" form. The final grade will be entered as I/final grade (e.g.., I/B+). An Incomplete grade that has not been amended by the Instructor within one term may be converted to an F (or NP for P/NP courses) by the Registrar.
